All other applicants **not previously** registered must present a copy of a current registration from another jurisdiction or two (2) separate proofs of work satisfactorily completed under permit and a list of work experience and education on the back of this sheet.

I hereby swear that all of the information is true to the best of my knowledge, that I am at least 18 years of age, able to interpret construction plans and specifications, and able to comply with the requirements of the Village of Jefferson Code of Ordinances.
