A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S), AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY

WHEREAS the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and,

WHEREAS the Village of Jefferson, Ohio is planning to make capital improvements to the wastewater treatment plant, such project to be called "WWTP EQ Basin" to improve and upgrade the wastewater treatment plant; and,

WHEREAS the infrastructure improvement herein described is considered to be a priority need for the community and is a qualified project under the Ohio Public Works Commission;

NOW, THEREFORE, BE IT RESOLVED BYTHE COUNCILOF THE VILLAGE OF JEFFESON, OHIO, THAT:

**SECTION 1.** The Village Administrator be and is hereby authorized to apply to the Ohio Works Commission for funds as described above, namely for the project called "WWTP EQ Basin."

**SECTION 2.** The Village Administrator is further authorized to enter into any agreements as may be necessary and appropriate for obtaining financial assistance to finance the project called "WWTP EQ Basin."

SECTION 3. It is found and determined that all formal actions of the Council of the Village of Jefferson concerning and relating to the adoption of this Resolution were taken in an open meeting of the Village of Jefferson and that all deliberations of this Village Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements, including Sections 121.22 of the Ohio Revised Code.

WHEREAS the Village of Jefferson wishes to apply for \$300,000 of ARC funding for the Jefferson WWTP EQ Basin; and,

WHEREAS the Village of Jefferson, Ohio will commit the local share of \$1,000,000, 23.1 % of the total project cost of \$1,300,000; and,

WHEREAS the infrastructure improvement herein described is considered to be a priority need for the community and is a qualified project under the ARC; and,

WHEREAS, it is the desire of the Village of Jefferson to designate an official to sign and submit this application and to execute contracts in connection with said application; and,

NOW, THEREFORE, BE IT RESOLVED BYTHE COUNCILOF THE VILLAGE OF JEFFESON, OHIO, THAT:

**SECTION 1.** The Village Administrator be and is hereby authorized to apply to the ARC for funds as described above.

**SECTION 2.** The Village Administrator is further authorized to enter into any agreements as may be necessary and appropriate for obtaining financial assistance to finance the Jefferson WWTP EQ Basin project.
