**A RESOLUTION APPROVING THE RATE SCHEDULE FOR SEWER RATES AS
AUTHORIZED IN CHAPTER 1030.18 OF THE CODE OF ORDINANCES
FOR THE VILLAGE OF JEFFERSON, OHIO**

WHEREAS Chapter 1030.18 of the Code of Ordinances for the Village of Jefferson, Ohio authorizes and directs the Village Administrator to annually propose for Council’s review and approval a rate schedule for sewer rates;

WHEREAS the Village Administrator has submitted the attached proposed rate schedule for sewer rates pursuant to Chapter 1030.18 of the Code of Ordinances for the Village of Jefferson, Ohio;

WHEREAS Council of the Village of Jefferson, Ohio has reviewed the attached proposed rate schedule for sewer rates as required by Chapter 1030.18; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JEFFERSON, COUNTY OF ASHTABULA, AND STATE OF OHIO, THAT:

SECTION 1. The attached proposed rate schedule for sewer rates is hereby adopted and approved pursuant to Chapter 1030.18 of the Code of Ordinances for the Village of Jefferson, Ohio.

SECTION 2. It is found and determined that all formal actions of the Council of the Village of Jefferson, Ohio concerning and relating to the adoption of this Resolution were taken in an open meeting of the Village of Jefferson, Ohio and that all deliberations of this Village Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution shall take effect and be in full force at the earliest period allowed by law.
