Dear Council Members,

I Councilperson Martuccio would like to lay out a path forward on this issue that we can all agree to.

We can all agree that, since the position of Clerk-Treasurer was established in our village, it has always been an elected office, with the people given the opportunity to choose their representative every four years. We can all agree that elected officials—whether council members, the mayor, or the Clerk-Treasurer—are chosen by the people to serve. And we can all agree that, as council members, we are accountable to our residents and voters.

If all of this is true, then why wouldn't we allow the people to decide on this important change?

If we approve this ordinance as written tonight, not only will we be taking away the people's right to vote for their Clerk-Treasurer, but we will also be taking away their right to determine whether this change is in the best interest of the village. We trust the electorate to choose a mayor, a council, and other officials—why should we not trust them with this decision as well?

And let's be honest—if we reject this amendment, we are essentially saying, "We don't trust the voters to make this decision." That is a tough stance to defend, especially when we were all elected by these very same voters. If we had enough faith in the people of Jefferson to elect us to office, why would we now turn around and take away their ability to vote on such a fundamental change?

We have **plenty of time** to put this issue on the ballot. In less than eight months, our voters will already be casting their ballots, making it the **perfect opportunity** to let them weigh in on this decision. There is no reason to rush this tonight when we can allow the voters to have their say at the next municipal election.

### Visitor's Comments (five-minute limit per council rule #13)

Citizen Hendrick Wolfert of 35 North Elm Street addressed the Council expressing concerns over the proposal to combine the elected positions of village clerk and treasurer into a single appointed fiscal officer. While acknowledging that Ohio law permits such a change, Wolfert argued that it undermines residents' right to vote on these crucial roles, reducing accountability and transparency. He emphasized that the people of Jefferson deserve the ability to choose those responsible for managing their finances. Despite concerns about unqualified candidates, Wolfert stated that the solution is to ensure voters have the necessary information, not to remove their right to choose. He also warned of potential conflicts of interest and reduced oversight, suggesting that the council, already divided, should avoid consolidating power. Wolfert stressed that making this change without a public vote disregards the will of the people and urged the council to place the issue on the ballot for residents to decide.

Citizen Frank Snyder of 72 East Jefferson Street, a former councilperson, expressed concerns about changing the Clerk-Treasurer position to an appointed role. He emphasized that the current elected position, with a four-year term, ensures the person is committed to the community, while an appointed position might lack that dedication. Snyder also noted the committee's worry that an appointed individual may not be adequately trained or experienced, despite the fact that the current Clerk-Treasurer has completed various state training programs. He suggested leaving the position as is and, if it becomes vacant after the term ends, allowing an appointment at that time. Snyder also questioned the urgency of the proposed change, given that the current Clerk-Treasurer has three years remaining in her term.

He said, currently, the mayor and the clerk are independent of each other, and they currently report to the residents of the Village.

Snyder also told the Council he understands that some members of council are concerned that an unqualified person could win the next election. "However, that risk exists with any elected office. The voters are the ones that we should trust to make to make decisions.

Mayor Chiacciero told the council the new Fiscal Officer would have to be an accountant to apply for the position.

Chairman Sekanina of the Finance Committee informed the Council that the Ohio Revised Code (ORC) allows a village to either elect a Clerk Treasurer or appoint a Fiscal Officer, with council approval. This issue was raised years ago, and the current Clerk Treasurer has stated she will not seek reelection and may not finish her term, expressing a desire for a qualified replacement. Concerns were raised that an unqualified person could be elected, with no recourse until the next election, as ORC does not require financial qualifications for the position. In contrast, the Fiscal Officer process would involve a hiring committee, with interviews and recommendations based on financial qualifications. The mayor would appoint the

individual, and the council would approve the appointment, with the possibility to waive residency requirements. The council can also change back to an elected position in the future, with a two-thirds vote. The mayor cannot remove the appointed Fiscal Officer without council approval, but the council can remove them with a three-quarters vote.

The hiring committee would be appointed by the mayor and would have to discuss what qualifications and experience they were looking for in this position, including salary. It is expected that it would be someone with experience in accounting or other financial background.

Chairman Sekanina of the Finance Committee, told Council right now in the State of Ohio out of six hundred and sixty Villages eight nine still have elected Clerk Treasurers and the rest are appointed.

#### **RESOLUTION NO. 2025 -R-\_\_\_3372\_\_\_\_**

## A RESOLUTION OPPOSING PROPOSED LEGISLATION (SENATE BILL 43) TO ELIMINATE A LODGING TAX WITHIN ASHTABULA COUNTY

WHEREAS, Senate Bill 43, introduced by Senator Sandra O'Brien, proposes changes that would negatively impact Ashtabula County by altering the funding mechanism for the Ashtabula County Convention & Facilities Authority (CFA), which has been instrumental in supporting the Geneva Lodge and Conference Center, as well as the county's broader tourism industry; and

WHEREAS, the Council of the Village of Jefferson believes that the passage of Senate Bill 43 would impose undue financial and administrative burdens on the village, its residents, and local governance, ultimately limiting the village's ability to promote economic development and tourism; and

**WHEREAS,** the proposed legislation would eliminate a vital lodging tax that funds the CFA, a tax that is visitor-generated and rarely, if ever, paid by village residents unless they are staying at a local lodging establishment; and

WHEREAS, without this lodging tax, the financial burden of supporting economic growth and tourism-related infrastructure would shift to village residents, placing an undue strain on local taxpayers; and

WHEREAS, funds generated from the lodging tax have significantly contributed to the county's, as well as the village's tourism industry, which currently has an annual economic impact of \$859.4 million, welcomed 19.5 million visitors in 2023, supports 4,082 jobs, and resulted in \$520.7 million in direct visitor spending, according to the Ashtabula County Visitors Bureau; and

WHEREAS, without tourism-generated state and local taxes, it is estimated each local household would need to pay an additional \$1,327 to maintain current government services; and

WHEREAS, this is a tax with a purpose, supporting continued growth in our tourism industry within the confines of the laws that govern convention and facilities authorities, just as it functions successfully in other parts of the state with similar CFAs; and

WHEREAS, this funding has not only supported the Geneva Lodge and Conference Center, ensuring its success and sustainability, but will also be utilized in the future to enhance tourism throughout Ashtabula County, including areas outside of Geneva-on-the-Lake, such as southern Ashtabula County, Ashtabula, Conneaut, Geneva, Jefferson, and beyond; and

WHEREAS, Senate Bill 43 was introduced without any prior consultation with county or village officials, tourism industry leaders, local stakeholders, or other relevant parties, leaving those directly impacted without a voice in the legislative process; and

WHEREAS, similar lodging tax structures exist successfully in other regions of Ohio to fund CFAs, and there is no justification for targeting Ashtabula County's successful model while allowing other counties to maintain their funding mechanisms; and

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JEFFERSON, COUNTY OF ASHTABULA, AND STATE OF OHIO, THAT:

**Section 1:** The Council of the Village of Jefferson Council of the Village of Jefferson hereby formally opposes Senate Bill 43 and urges the Ohio General Assembly to reject this legislation in its current form.

#### ORDINANCE NO. 2025-O-\_\_3373\_\_\_\_

#### AN ORDINANCE AMENDING CHAPTER 254.05 OF THE CODE OF ORDINANCES OF THE VILLAGE OF JEFFERSON, OHIO PERTAINING TO OVERTIME

**WHEREAS**, Council has been advised of the need to provide for the amendment of Chapter 254.05 of the Code of Ordinances of the Village of Jefferson, Ohio pertaining to overtime.

WHEREAS, Chapter 254.05 presently reads as follows:

#### § 254.05 OVERTIME.

- (a) With the exception of hourly employees of the Village of Jefferson Police Department, all hours worked outside a full-time employee's scheduled 40 hours of work shall be paid at one and one halftimes the employee's normal hourly rate of pay. In addition, any other employee who works more than 40 hours in a work week is entitled to overtime pay for all hours worked in excess of 40 hours at one and one halftimes their normal rate of pay. With respect to hourly employees of the Village of Jefferson Police Department only, all hourly employees of the Village of Jefferson Police Department who work more than 80 hours in a work period are entitled to overtime pay for all hours worked in excess of 80 hours in that work period at one- and one-half times their normal rate of pay. With respect to all hourly employees for the Village of Jefferson, absences during a work week or work period due to unpaid leave, disciplinary time off, and sick leave are not included as hours worked for purposes of determining an employee's entitlement to overtime pay.
- (b) Full time employees who are scheduled to work Monday through Friday as workdays and have to work on a day scheduled off as a holiday will be compensated for working on that holiday at a rate one and one-half times their normal rate of pay.
- (c) Full time employees, part time employees and auxiliary/seasonal/temporary employees who are scheduled to work on Saturday and/or Sunday will be paid one and one-half times their normal rate of pay for working on the actual holiday rather than a scheduled Monday or Friday holiday being observed by those who work a Monday through Friday schedule.

WHEREAS, Council finds it to be in the best interest of the Village to provide for the amendment of Chapter 254.05 of the Code of Ordinances of the Village of Jefferson, Ohio.

### NOW, THEREFORE, BE IT RESOLVED AND ORDAINED BY THE COUNCIL OF THE VILLAGE OF JEFFERSON, ASHTABULA COUNTY, STATE OF OHIO:

Section 1. That Chapter 254.05 of the Code of Ordinances of the Village of Jefferson, Ohio is hereby amended to read as follows:

#### **§ 254.05 OVERTIME.**

(a) With the exception of hourly employees of the Village of Jefferson Police Department, all hours worked outside a full-time employee's scheduled 40 hours of work shall be paid at one and one halftimes the employee's normal hourly rate of pay. In addition, any other employee who works more than 40 hours in a work week is entitled to overtime pay for all hours worked in excess of 40 hours at one and one halftimes their normal rate of pay. With respect to hourly employees of the Village of Jefferson Police Department only, all hourly employees of the Village of Jefferson

Police Department who work more than the regularly scheduled 80 hours in a work period are entitled to overtime pay for all hours worked in excess of the regularly scheduled 80 hours in that work period at one- and one-half times their normal rate of pay. With respect to all hourly employees for the Village of Jefferson, absences during a work week or work period due to unpaid leave, disciplinary time off, and sick leave are not included as hours worked for purposes of determining an employee's entitlement to overtime pay. Holiday time off shall be counted as hours worked for purposes of calculating entitlement to overtime pay for all hourly employees except for hourly employees of the Village of Jefferson Police Department.

- (b) Full time employees who are scheduled to work Monday through Friday as workdays and have to work on a day scheduled off as a holiday will be compensated for working on that holiday at a rate one and one-half times their normal rate of pay.
- (c) Full time employees, part time employees and auxiliary/seasonal/temporary employees who are scheduled to work on Saturday and/or Sunday will be paid one and one-half times their normal rate of pay for working on the actual holiday rather than a scheduled Monday or Friday holiday being observed by those who work a Monday through Friday schedule.

Section 2. That any and all ordinances or parts thereof in conflict with this Ordinance shall be and the same are hereby repealed.

Section 3. That all formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and all deliberations of this Council, or any of its committees, which resulted in such formal actions, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**WHEREFORE,** this Ordinance shall take effect and be in force from and immediately upon its passage.

#### ORDINANCE NO. 2025-O-\_\_\_3374\_\_\_\_

## AN ORDINANCE COMBINING THE DUTIES OF THE ELECTED VILLAGE CLERK AND THE ELECTED VILLAGE TREASURER INTO ONE APPOINTED OFFICE, TO BE KNOWN AS VILLAGE FISCAL OFFICER

WHEREAS, the Village of Jefferson, Ohio finds that Ohio Revised Code Section 733.262 permits the combination of the duties of two elected Village Offices, that being Village Clerk and Village Treasurer, or the combined elected office of Village Clerk-Treasurer, into one appointed office, to be known as the Village Fiscal Officer; and

**WHEREAS**, the Village of Jefferson, Ohio currently has a combined elected office of Village Clerk-Treasurer; and

WHEREAS, the Village of Jefferson, Ohio desires that in lieu of having a combined elected office of Village Clerk-Treasurer, it shall have a Village Fiscal Officer as appointed by the Mayor and approved by the Village legislative authority.

## BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF JEFFERSON, OHIO, TWO-THIRDS OF ALL MEMBERS ELECTED THERETO CONCURRING, THAT:

- <u>Section 1.</u> The duties of the combined elected office of Village Clerk-Treasurer is hereby combined into one appointed office, to be known as the Village Fiscal Officer.
- Section 2. A certified copy of this Ordinance shall be filed with the Ashtabula County Board of Elections not less than one hundred and twenty (120) days before the day of the next succeeding municipal primary election at which candidates for the combined office of Village Clerk-Treasurer are to be nominated or not less than one hundred twenty (120) days before the next succeeding regular municipal election at which the combined office of Village Clark-Treasurer is to be elected, whichever applies.
- <u>Section 3.</u> The Village Fiscal Officer appointed shall perform the duties provided by law for the Village Clerk and Treasurer and any other duties consistent with the nature of the office as provided for by ordinances of the Village of Jefferson.
- <u>Section 4.</u> The Village Fiscal Officer shall be appointed by the Mayor of the Village of Jefferson. That appointment does not become effective until it is approved by the majority vote of the Council of the Village of Jefferson.
- <u>Section 5.</u> Pursuant to Ohio Law, the change to the appointed position of Village Fiscal Officer shall be effective on the first day of January following the next regular municipal election at which the Village Clerk, Village Treasurer, or Village Clerk-Treasurer is to be elected.

Section 6. Pursuant to Ohio Revised Code Section 733.262. the Village Fiscal Officer need not be an elector of the Village of Jefferson or reside within the Village limits at the time of the appointment; however, the Village Fiscal Officer shall become a resident of the Village of Jefferson within (6) months after the appointment takes effect unless an ordinance is passed approving the Village Fiscal Officer's residence outside of the Village of Jefferson.

<u>Section 7.</u> This Ordinance shall take effect and be in force on the earliest date allowed by law.

#### Statement for the Record:

Dear Mayor, Council Members, and Jefferson Residents,

At our last meeting, **Councilman Steve Sekanina improperly objected** to my amendment being placed on the agenda, citing decorum and a supposed lack of 24-hour notice—both of which are **procedurally invalid objections** under *Robert's Rules of Order*. The motion to amend was introduced at the appropriate time under "Additions and Corrections to the Agenda," following standard council procedures.

However, I would like to highlight some key facts regarding this ordinance as currently written:

- The ordinance is being passed now but will not take effect for three years. Even if the current Clerk-Treasurer were to retire tomorrow or next year, the position would, by law, still need to be filled by someone who meets the current elected Clerk-Treasurer requirements—including residency and term limits. This is similar to how we replace a vacant Council or Mayor's seat. While I agree with my colleagues that ensuring a qualified individual holds this position is important, this decision does not need to be rushed at this time.
- 2) The decision to make this an appointed position should be left to the voters. The next municipal election is less than eight months away, making it the perfect opportunity to let the people decide whether this position should remain elected or transition to an appointed role. While some may argue that Council should make this decision on behalf of the public, I firmly believe that taking this choice away from voters—when we have ample time to place it on the ballot—is neither wise nor appropriate.

As of today, 444 people have viewed our last council meeting, showing a high level of public interest in this matter. Given that level of engagement, I urge my fellow Council Members to reflect carefully on whether we should be taking this decision away from the electorate we serve.

Unfortunately, due to pre-existing travel plans, I will not be able to attend the **April 21st meeting** for the third reading of this ordinance. However, I **trust that the Mayor and Council will make the right decision** in my absence.

**SECTION 1.** Mayor James Chiacchiero's appointment of Steven S. Murphy as Village Administrator of the Village of Jefferson, Ohio is hereby approved.

**SECTION 2.** The Village of Jefferson agrees to employ the services of Steven S. Murphy according to the terms of the Village of Jefferson's Employee Handbook/Personnel Policy Manual, Chapter 254 of the Village of Jefferson's Codified Ordinances, and the conditions and stipulations contained in the Employment Agreement attached hereto and incorporated herein by reference.

**SECTION 3.** This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the Village of Jefferson, Ohio, such emergency arising out of the necessity to hire an Administrator to ensure the uninterrupted provision by the Village of public services and the proper supervision of Village employees and departments, and shall take effect and be in force immediately after its passage.

#### EMPLOYMENT AGREEMENT

This Employment Agreement (hereinafter "Agreement") is between the Village of Jefferson of 27 East Jefferson Street, Jefferson, Ohio 44047, (hereinafter "Village"), and Steven S. Murphy, 520 Ruth St, Geneva, Ohio 44041, (hereinafter "Village Administrator").

#### A. Consideration

- a. The Village of Jefferson is a statutory village and municipal corporation as defined by the Ohio Revised Code.
- b. The Village desires to obtain the services of Steven S. Murphy as its Village Administrator and Steven S. Murphy is willing to serve the Village in that capacity.
- c. The consideration for this agreement consists of the mutual promises of the parties and the benefits expected to accrue to each from their association.

#### **B.** Duties

- a. The Village Administrator shall be under the general supervision and control of the Mayor.
- b. The Village Administrator shall have those powers, duties, and functions as provided by the general laws of the State of Ohio including, but not limited to, Ohio Revised Code §735.273.
- c. The Village Administrator shall also have those powers, duties, and functions as provided by the Codified Ordinances of the Village of Jefferson including, but not limited to, Chapter 232.
- d. In addition to the above, the Village Administrator shall have those powers, duties, and functions as directed by the Mayor.

#### C. Performance of Duties

- a. The Village Administrator will devote his time, skill, and best efforts to the duties of his employment.
- b. The Village Administrator agrees to abide by the policies and rules of the Village and to perform any and all duties lawfully required of his in the course of his employment faithfully, honestly, diligently, and in a careful and workmanlike manner to the Village's satisfaction.
- c. The Mayor and/or Council shall annually review and evaluate the Village Administrator in advance of the adoption of the annual budget.
- d. The Village Administrator shall attend all Council Meetings and Council Committee meetings, unless excused by the Mayor and/or Council.
- e. The Village Administrator is an exempt salaried employee of the Village and is expected to work a minimum of forty hours per week and may be required to work additional hours as directed by the Mayor or necessitated by emergency situations as they arise.
- f. In the event the Village Administrator works significantly more than 40 hours in a week, then the Village Administrator may request compensatory time off, approved at the discretion of the Mayor and scheduled at such a time that is mutually agreeable between the Mayor and the Administrator.

- g. The Village agrees to budget and pay for those dues, subscriptions, and training of the Village Administrator that are deemed necessary for his continued employment, professional growth, and advancement, as well as those that are deemed for the good of the Village, as approved by Council in advance.
- h. The Village further agrees to budget and pay for those dues, subscriptions, and training that are deemed necessary for the Village Administrator's full participation in national, regional, state, and local associations, as approved by Council in advance.
- i. The Village shall reimburse the Village Administrator for travel, lodging, subsistence, and other reasonable and necessary expenses incurred by him in the performance of his duties as outlined by the Village's rules including, but not limited to, the Village of Jefferson Employee Handbook/Personnel Policy Manual and Chapter 254 of the Codified Ordinances of the Village of Jefferson.

#### D. Residency

- a. The Village Administrator is a resident of the Village and shall remain a resident of the Village throughout the term of this Agreement, unless the residency requirement is waived by council by ordinance.
- b. In the event the Village Administrator ceases to be a resident of the Village for any reason, this Agreement shall immediately terminate.

#### E. Salary

- a. The Village shall pay to the Village Administrator an initial salary of \$85,000 per year payable in bi-weekly installments, for his services.
- b. The Village Administrator's salary shall be subject to an annual performance review and may be increased by Council, from time to time, as recommended by the Mayor and approved by Council.
- c. If the Village Administrator receives a satisfactory performance review, then he shall be granted a salary increase equal to the percentage increase granted to all Village employees.

#### F. Benefits

- a. The Village Administrator shall be entitled to any and all other benefits as more particularly described in the Village of Jefferson Employee Handbook/Personnel Policy Manual and Chapter 254 of the Codified Ordinances of the Village of Jefferson. However, in the event this Agreement provides for greater benefits than those contained in the Village of Jefferson Employee Handbook/Personnel Policy Manual and Chapter 254 of the Codified Ordinances of the Village of Jefferson, the Village Administrator will be entitled to the benefits set forth in this Agreement.
- b. The Village shall pay the Village Administrator's contribution to PERS in the manner in which it does for all other Village employees.
- c. The Village will furnish to the Village Administrator, at the Village's expense, a vehicle suitable for use in carrying out his employment responsibilities.
- d. The Village Administrator shall be entitled to four weeks of paid vacation annually, which shall accrue on each Anniversary Date. Notwithstanding the

- foregoing, upon execution of this Agreement, the Village Administrator shall accrue one week of paid vacation.
- e. The Village Administrator shall be entitled to the same number of personal days annually that all other employees of the Village are entitled to pursuant to Section 254.063(c)(5) of the Codified Ordinances of the Village which shall accrue on the Anniversary Date of this Agreement.
- f. After completion of the initial three-year term of this Agreement, the Village Administrator shall be entitled to an additional week of vacation, for a total of five weeks annually.
- g. The Village Administrator shall be entitled to the same medical benefits provided to other employees of the Village. In addition, the Village will pay all of the Village Administrator's health insurance premiums arising from the medical benefits provided by the Village, as well as all deductible (HAS) contributions.

#### G. Term

- a. This Agreement shall be in force for an initial term of three years.
- b. Beginning on the "hire date" set forth below, the Village Administrator shall serve a six-month probationary period and may be removed during this probationary period with or without cause by the Mayor with the consent of a majority of the members elected to Council notwithstanding any provision to the contrary in Chapter 254 of the Codified Ordinances of the Village of Jefferson.
- c. On each Anniversary Date of this Agreement following the expiration of the initial term or the expiration of any renewal terms as contemplated herein, this Agreement shall be automatically extended for an additional period of two (2) years, on the same terms and conditions as herein provided, unless otherwise agreed to in writing. Either party may prevent the automatic extension of this Agreement upon written notice to the other party of their intention not to extend this Agreement no less than 120 days from the Anniversary Date.
- d. Notwithstanding the Term of this Agreement, the Village may terminate the Village Administrator, with or without cause, at any time, and nothing in this Agreement shall be construed as preventing or otherwise limiting the right of the Village to terminate the services of the Village Administrator, at any time, for any reason, subject to the Severance Pay provision outlined below.
- e. The Village Administrator shall serve at the pleasure of the Mayor and Council of the Village and may be removed without cause by the Mayor with the consent of a majority of the members elected to Council.
- f. The Village Administrator may also be removed without cause by the affirmative vote of three-fourths of the members elected to Council without the consent of the Mayor pursuant to Revised Code §735.271.

#### H. Severance Pay

a. In the event the Village Administrator is terminated by the Village for a reason other than those identified in Section H(b) of this Agreement before the expiration of the initial or extended term of this Agreement and at a time when the Village Administrator is willing and able to perform his duties under this Agreement, then

- the Village agrees to pay the Village Administrator a lump sum payment equal to two months gross salary, minus deductions.
- b. If the Village Administrator is terminated by the Village for any of the following reasons, he shall not be entitled to severance pay defined in Section (H)(a) above:
  - i. Termination while serving his probationary period;
  - ii. Death of the Village Administrator;
  - iii. Retirement of the Village Administrator;
  - iv. Any act or omission by the Village Administrator that subjects the Village to civil or criminal liability;
  - v. Any act or omission by the Village Administrator that tends to injure the Village's business or reputation;
  - vi. Failure of the Village Administrator to perform his duties specified in this Agreement;
  - vii. Failure of the Village Administrator to be a resident of the Village of Jefferson unless previously waived by Council;
  - viii. Refusal or cancellation of a bond intended to cover the Village Administrator; or
  - ix. Expiration of the original or extended term of this Agreement upon the 120 days written notice of intention to not extend contemplated in Section G of this Agreement.

#### I. Bond

- a. The Village Administrator shall be bonded as a condition of employment, by a fidelity bond issued by a bonding company satisfactory to the Village, in an amount designated by the Village.
- b. The bond premiums shall be paid by the Village.
- c. If issuance of a bond is refused, or if the bond is canceled after issuance, then the Village Administrator shall be terminated.

#### J. Hiring Date

- a. The Village Administrator shall commence employment with the Village as of the date of this Agreement, which shall be considered the date of hire.
- b. The Anniversary Date of this Agreement shall be the date of this Agreement.

#### K. Miscellaneous

- a. The Village Administrator shall not become an elected official of, or a candidate for elected office for, the Village during his tenure as Village Administrator, nor shall he assume any other position, elected or otherwise, that would constitute a conflict of interest.
- b. This Agreement constitutes the entire agreement between the parties as to the Village Administrator's employment relationship with the Village of Jefferson and no modification hereof shall be binding upon the parties unless it is in writing and signed by both parties.
- c. This Agreement shall bind and benefit the parties and their respective legal representatives, executors, administrators, successors, and assigns.

- d. This Agreement shall be construed under and in accordance with the laws of the State of Ohio.
- e. If any clause or provision of this Agreement shall be adjudged invalid or unenforceable by a court of competent jurisdiction, or by operation of any applicable law, it shall not affect the validity of any other clause or provision of this Agreement, which shall remain in full force and effect. Each of the provisions of this Agreement shall be enforceable independently of any other provision of this Agreement, and independently of any other claim of action.
- f. The waiver of a breach of any provision of this Agreement by either party shall not operate or be construed as a waiver of any subsequent breach.

#### ORDINANCE NO. 2025-O-\_\_3378\_\_\_\_

## ORDINANCE WAIVING THE REQUIREMENT THAT THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF JEFFERSON RESIDE IN THE VILLAGE FOR THE PURPOSE OF APPOINTING AND HIRING STEVEN S. MURPHY AS THE VILLAGE ADMINISTRATOR AND DECLARING AN EMERGENCY

WHEREAS, the Mayor has appointed Steven S. Murphy as the Village Administrator and Council has confirmed that appointment; and

WHEREAS, Ohio Revised Code, §735.271 states that any person appointed as the Village Administrator need not be an elector or reside in the Village at the time of the appointment, however, the person must become a resident of the Village within six months after the appointment and confirmation by Council unless the person's residence outside the Village is approved by ordinance;

WHEREAS, ORC §735.271 allows Council to waive this residency requirement via Ordinance

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF JEFFERSON, COUNTY OF ASHTABULA, AND STATE OF OHIO, THAT:

- **Section 1:** The Village of Jefferson hereby waives the requirement of ORC §735.271 that the Village Administrator must reside in the Village, subject to the limitations herein.
- **Section 2:** This waiver shall only apply to the appointment and term of Steven S. Murphy as Village Administrator. Any and all future appointments to the Village Administrator position shall be subject to the residency requirement unless likewise waived by Ordinance.
- **Section 3:** That all formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and all deliberations of this Council, or any of its committees, which resulted in such formal actions, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- **Section 4:** This Ordinance is hereby declared to be and is passed as an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Jefferson and shall be effective upon its passage.
